SUBJECT: Annual Report from the Court Security Commission as required by
Wyoming Court Security Act, W.S. 5-11-101 et seq.

On behalf of the Court Security Commission, I respectfully present to you the 2015 Annual Report. This past year, the Commission has continued to fulfill its statutory endeavor to protect life, property and the judicial process in the Wyoming court system.

In a coordinated effort with the National Center for State Courts, the Commission completed security assessments in eight counties across Wyoming. With the support of the Legislature, including Senator Drew Perkins and Representative Kendell Kroeker, \$1,083,422 was appropriated for court security improvements in the eight counties: Platte (\$84,429.00), Goshen (\$84,686.00), Niobrara (\$73,778.00), Albany (\$95,355.00), Big Horn (\$371,790.00), Crook (\$82,778.00), Park (\$82,760.00), and Weston (\$207,846.00). These funds were provided to seven of the eight counties (many designated as hardship counties) on a 90/10 matching funds basis. The initial assessments were funded by a grant from the State Justice Institute, as reported in the 2014 Annual Report. The court security funding process in Wyoming has been an exercise in good government – all three branches worked together to provide resources and quality service to the citizens of this state.

Additionally, the Commission increased its efforts to bring awareness to the potential security risks and actual courthouse security incidents in Wyoming by adopting an incident reporting standard. Wyoming Court Security Standard 2014-1 tasks local officials with reporting court security issues to the Commission and their local management committees.

The Commission stands committed to its charge of working to promote safe and secure environments for our public officials and the citizens who frequent our courthouses across the state.

Re: Report on Court Security Funds

Date: September 1, 2015

In 2014, the Legislature appropriated \$6,000,000 to be used by the State Loan and Investment Board to issue grants to Fremont and Sweetwater County for court security improvements. The Board approved a grant for \$2,565,515 for Fremont County on June 5, 2014. On June 19, 2015 Fremont County dedicated the new Riverton Justice Center. On April 9, 2015, the State Loan and Investment Board approved a grant for \$3,434,485 to build a new justice center in Sweetwater County. The estimated total cost of the project is \$19,500,000.

During the 2015 General Session, the Wyoming Legislature appropriated \$1,083,422.00 for the State Loan and Investment Board to authorize grants to eight additional counties. The eligible counties may apply for grants to pay for court security improvements including the purchase of security equipment within courthouses or construction or modification of facilities containing a state court. The authorized counties and funding are:

On June 4, 2015, the State Loan and Investment Board approved a grant to Goshen County for \$84,686 for improvements to be undertaken as recommended by the National Center for State Courts review of the Goshen County Courthouse. The Court Security Committee will pursue completion of as many of the items in the report as financially possible, along with any projects needed to help complete the goals. The County proposed to match this grant with \$9,409 from Homeland Security or Community Development Block Grant funds or from the county's general fund.

The State Loan and Investment Board also approved a \$95,355 grant for Albany County on August 13, 2015. Albany County will use the funds to address seven issues that will improve security for the Albany District and Circuit Courts. The County proposed to match the grant with \$10,000 from Homeland Security and \$5,000 from the Albany County Bar Association.

I. Courthouse Construction

The Sweetwater County Commissioners signed a Resolution on November 12, 1980, and resolved to establish a county court system in Sweetwater County. The Resolution requested there be two county court judges, with one judge located in Green River and one judge located in Rock Springs. In July of 2000, the Wyoming Legislature created a court structure such that the county courts and the justice of the peace courts would be consolidated into one circuit court system (2000 Wyo. Laws, 61). Sweetwater County currently has two separate facilities constituting the circuit court, with one court located in Green River and one court located in Rock Springs.

During the 2014 Budget Session, the Wyoming Legislature authorized and funded the Court Security Funding Program (2014 Wyo. Sess. HEA 41, Section 328), and the Sweetwater County Commissioners applied for and received grant funds for court security improvements from the State Loan and Investment Board. Along with a plan to improve court security, the Sweetwater County Commissioners decided to merge the two circuit courts into one. A new Justice Center will be built midway between Green River and Rock Springs and will house both circuit court judges and their staff.

II. Merger of Circuit Courts

Plans for merger of Sweetwater County's circuit courts is on schedule. On July 21, 2015, the Sweetwater County Commissioners approved floor plans for buildings which will house both circuit courts, sheriff's administration office, county attorney and public defender. The buildings will be co-located adjacent to the Sweetwater County Detention Center on Highway 191 South. By relocating Circuit Court West from the county courthouse, additional space will be available for the county's district judges. At the July 21, 2015, commissioner meeting Tom Brennan of EDA Architects briefed commissioners on current plans, the structure and costs. It was decided to include additional space for a data center to support the IT needs of county and state agencies using the location.

Design themes have focused on functionality and security. Critical in this plan is the location next to the detention center (built in 2005) and the underground walkway from the jail to the court facility. With the "tunnel," inmates can enter the court facility without leaving a secure zone. At the court's end of the tunnel, an elevator and stairs provide ADA compliant access to holding cells

between the courtrooms. Inmates will no longer travel by van 5 and 7 miles to appear in circuit court.

Planning for the new Justice Center is focusing on final budgetary analysis. All stakeholders are completing room design questionnaires. Staff emphasized the need for efficiency. Plentiful electrical outlet placement is at the head of the list. In terms of audio visual needs, the goal is complete integration. Hardware such as smart boards along with components capable of running the latest trial presentation software are high on the list of necessities. State of the art technology will allow virtual appearances by inmates and litigants. Long term cost savings will be realized if judges can avoid travel to hear conflict cases or simply fill in when needed in distant courts. All stakeholders thank the county commissioners of Sweetwater County and recognize the hard work of Chuck Radosevich, facilities manager for Sweetwater County. The project will be let out for bid in late 2015, with plans to break ground in the spring of 2016. Ideally, occupancy will occur in late 2017 or early 2018.

The Wyoming Court Security Commission (Commission) continues to make progress in fulfilling its goal of enhancing court security in Wyoming by partnering with the Court Security Management Committees (local committees), established by Wyoming Court Security Standard 2009-1.

Over the past year, as one of its main objectives, the Commission focused its efforts on increasing awareness of potential court security situations and risks associated with courthouses across the state. In an effort to increase security awareness, at its December 12, 2014 meeting, the Commission adopted Wyoming Court Security Standard 2014-1 – Incident Reporting. Situational awareness of security incidents and communication regarding the strengths and weaknesses identified in the response to the incident are keys to keeping Wyoming's courthouses safe for the public and employees that work there. Standard 2014-1 tasks local officials with submitting incident reports to the Commission as well as to their local management committees for security incidents in their counties.

A standardized Incident Report Form was developed and disseminated throughout the state. On January 1, 2015, the reporting standard was initiated. Incident reports submitted to the Commission are compiled in a data-base managed by the Wyoming Supreme Court.

The incident reporting process began slowly, with just 4 reports submitted through March of 2015. After additional educational efforts on the reporting process, more incident reports were submitted. As of August, 2015, 41 Security Incident Reports have been submitted to the Commission.

In addition to adopting the incident reporting standard, the Commission standardized the annual court security report form, as required by Wyoming Court Security Standard 2009-1. Each Court Security Management Committee is tasked with providing an annual report to the Commission, detailing the status of court security in their respective county. The updated standardized Annual Report Form was developed based on the 5 security standards established by the Commission. This report form was used for the annual reports submitted in July of this year, and the Commission is very pleased to report that all court security management committees submitted a 2015 report. Additional work with the management committees will be done in the next year to develop the content of the annual reports.

Both the Security Incident Report Form and the Standardized Annual Report Form have enhanced the intelligence gathering process in courthouses across the state, and furthers the Commission's ability to carry out its very important work.

III. Approval of July 30, 2014 Minutes

Chairman Cameron entertained a motion to approve the Wyoming Court Security Commission Meeting Minutes of July 30, 2014. Justice Hill made a motion to approve the minutes. Judge Tyler seconded the motion and the motion carried unanimously.

IV. National Center for State Courts (NCSC) Grants Update and Assessments – Eydie Trautwein and the National Center of State Courts

Eydie Trautwein, Children’s Justice Project Coordinator for the Wyoming Supreme Court, provided background information to the commission regarding two grants the Wyoming Supreme Court received relating to court security through the State Justice Institute. The first grant awarded \$50,000 funding to conduct court security assessments around the state. The second grant awarded \$30,000 funding to conduct regional trainings around the state related to court security. The Wyoming Supreme Court was notified in July these grants were awarded and the Wyoming Supreme Court immediately entered into a contract with the National Center for State Courts (NCSC) to help with further activities outlined in the grants.

The Court Security Assessment Grant provided security assessments for eight courtrooms around the state: Albany County, Platte County, Goshen County, Niobrara County, Weston County, Crook County, Big Horn County and Park County. Final drafts of these reports will be distributed to commission members, county commissioners, sheriffs and judges.

The Wyoming Supreme Court hosted regional trainings around the state. Approximately 160 personnel attended these trainings. After the trainings, the National Center for State Courts produced an evaluation report. The survey responses were very positive and ranked 7.3 out of a total 8.0 score. The actual trainings were recorded; however, the Wyoming Supreme Court is in negotiations with the NCSC to see if, and how, this training can be redelivered.

The National Center for State Courts was able to develop, in addition to the regional trainings, a shorter training that could be delivered by local law enforcement; in case there was a request for local court security trainings after the training grant was finalized.

Nathan Hall from the National Center for State Courts indicated that the assessments are based on best practices in court security. The suggested recommendations relate to communication and facilitation of court security committees, equipment and infrastructure. Security equipment costs for example would include security cameras, but installation costs would not be covered.

Steve Berson from the National Center for State Courts, reported in reviewing courtrooms in Wyoming to courtrooms in other parts of the country, there is opportunity for improvement. Many things can be done with little or no expense. For example, closing and locking doors, appropriate policies and procedures, emergency and evacuation drills, etc.

Chairman Cameron indicated the assessment costs were listed in three categories: Category A - Items that can be accomplished relatively quickly with little or no cost. Category B - Items that will entail a moderate amount of cost and time to implement. Category C - Items that will require a more significant amount of cost and time to implement. Within each of these three categories, the items are prioritized according to the risk management involved, with those items posing the most risk for the courts listed first. A range of potential cost implications are also presented. The summary of estimated cost implementing recommendations in all eight courthouses is \$1.2M, which does not include labor.

Eydie Trautwein indicated there is opportunity for additional training. Three training videos will be sent to the Wyoming Law Enforcement Academy and each county court security committee, which includes the judge and sheriff of each county, for training purposes. The final draft report of the Overview of Courthouse Security Assessments, excluding the individual court summaries, will be sent to each county court security committee for informational purposes in order for them to conduct their own assessments.

V. Legislative Initiatives and Activities – Chairman Cameron

Director Cameron indicated to varying degrees each of the eight courthouses has some good elements in place in the way of basic security measures, but more improvement is needed. Unfortunately, county funding is not available to enhance courthouse security. Director Cameron and Chief Justice Burke met with Senator Drew Perkins and Representative Kendall Kroeker, members of this

commission, for their leadership and direction with the legislative effort to build upon the momentum from Senate File 14 a year ago.

Representative Kroeker indicated that an individual bill will be drafted, or a supplemental budget request similar to the process during the 2014 Legislative Session. This bill will focus on the eight county courts which are the most vulnerable as addressed in the National Center for State Courts Overview of Courthouse Security. If the court qualifies for a hardship county, the state will contribute 90% toward the county court needs and the local county will contribute 10%. If the court does not qualify for a hardship county, it could be a 50/50 match between the state and the county.

VI. Incident Report Form and Local Court Security Management Committee Annual Report Template – Joe Hartigan

Joe Hartigan, Court Security Officer for the Wyoming Supreme Court, explained in detail to the commission members the draft of the Wyoming Court Security Incident Report Form. Mr. Hartigan suggested at the last Court Security Commission meeting in July, an incident reporting form be established in Wyoming, as it is in a number of states. It was agreed that the Wyoming Supreme Court would establish a draft security incident report form and present it at the Circuit and District Judges' Conferences, as well as the Court Clerks' Conferences. The feedback has been positive, even though the form has not been formally accepted. Director Cameron suggested a court security standard be drafted to task local court security committees to submit an incident report. This incident report form will be available on the Wyoming Supreme Court website. This report is designed for easy access and to collect data and statistics. This court security incident report will enhance reporting from the local court security committees. Steven Dreher, Chief Information and Technology Officer for the Wyoming Supreme Court, will compile this information. There was discussion of the possibility of a supplemental report referring back to the original incident report. A motion was made by Judge Roberts Item #13 on the Wyoming Court Security Incident Report titled, "Description of the Incident" be a mandatory requirement to be completed before submission if the local court security committee chooses to use this incident report form. The motion was seconded by Justice Hill and the motion carried unanimously. A motion was made by Judge Roberts that the Wyoming Court Security Incident Report must be submitted not later than five business days after the date the incident occurred. The motion was seconded by Justice Hill and Sheriff Hornecker. The motion carried unanimously.

VII. Wyoming Court Security Standard 2014-1 – Joe Hartigan

Joe Hartigan, Court Security Officer for the Wyoming Supreme Court, introduced to the commission members a draft report of the Wyoming Court Security Standard 2014-1, which establishes, "Incident Reporting." This standard's intention is to use this data from the incident report to strengthen court security around the state and eliminate any deficiencies that are detected following security incidents. All courts are tasked with submitting the Wyoming Court Security Incident Report within five business days of an incident's occurrence. Judge Wesley Roberts made a motion to adopt the Wyoming Court Security Standard 2014-1, "Incident Reporting." The motion was seconded by Judge Tyler and Justice Hill. The motion carried unanimously. Director Cameron indicated that the Wyoming Court Security Standard 2014-1 will be sent to Wyoming judges and the local court security committees. The official due date for the local court security committees annual report is July 1, 2015.

VIII. Efforts to strengthen Local Court Security Management Committees – Director Cameron

Director Cameron gave background information with regard to the Local Court Security Management Committees Annual Report. The Court Security Standards Checklist became the reporting instrument for the local court security committee's annual reports. The checklist did not elaborate on the efforts at the local level. A narrative form with detailed information with specific questions and assessments is needed.

Judge Marvin Tyler reported to the commission members that the District Judges Conference was recently held in December. Judge Tyler indicated that the Wyoming Court Security Standard 2009-1 was discussed at this meeting. This standard establishes the local court security committee and the district judge and others provide representation on the local committee. Each local committee shall elect a chairperson who will be the primary point of contact representing the local committee. Judge Tyler reported the district judges passed a resolution to recommend to the Wyoming Court Security Commission to amend the Wyoming Court Security Standard 2009-1; to require a district court judge chair each local court security committee, with the proviso that the judge can delegate chair duties to another member of the committee. This will ensure that a member of the local court security committee will be identifiable for each committee.

Judge Roberts suggested, and the commission members agreed, this amendment to the Wyoming Court Security Standard 2009-1 be tabled for any further action. This resolution will be requested to be placed on the agenda for

consideration at the next meeting of the Board of Judicial Policy and Administration.

IX. Adjournment

Chairman Cameron thanked everyone for attending the meeting. The meeting adjourned at 12:08 pm. A special meeting of the Wyoming Court Security Commission will be scheduled in April 2015.

Wyoming Court Security Commission
Minutes
April 17, 2015

The Wyoming Court Security Commission met on April 17, 2015. In attendance were Director of Homeland Security Guy Cameron, Chair, Justice William U. Hill, Judge Wes Roberts (by video), Judge Marv Tyler (by video), Representative Mark Baker (by video), Senator Leland Christensen, Sheriff Jack "Skip" Hornecker (by phone), and Sweetwater County Attorney Daniel Erramouspe (by video). Chief Justice Burke, Lily Sharpe, Joe Hartigan, Becky Craig, Doug Gumm and Ronda Munger also attended. Commission members Mike Thompson and Mike Colling were unavailable to attend.

Call the Meeting to Order

Director Guy Cameron called the meeting to order. He welcomed the newest members of the Commission – Senator Leland Christensen, Teton County (Senate District 17), Representative Mark Baker, Sweetwater County (House District 48), and Sweetwater County Attorney Daniel Erramouspe. Director Cameron gave a brief history of the Court Security Commission for the benefit of the new members. The Commission was established by the Wyoming Legislature in 2008, and operates under the supervision of the Wyoming Supreme Court. The Commission consists of 10 members, which were listed. The Commission is charged with establishing standards to protect life, property and the judicial process in the Wyoming court system. The standards adopted by the Commission are voluntary standards. The standards discuss equipment, facilities, architecture, and basic training requirements for peace officers. The standards also address protocols and procedures for operation of courts, as well as the establishment of local court security committees. The Commission meets at least two times a year and must report annually to the Governor, Chief Justice, Joint Judiciary interim committee and the Joint Appropriations committee.

The December 12, 2014 minutes were discussed. Two corrections were proposed and agreed upon. Senator Christensen moved and Justice Hill seconded a motion to approve the minutes as amended. Motion carried unanimously.

Legislative Update

Director Cameron gave an update on the court security assessments and grant funds. The Fremont and Sweetwater county projects are well underway and making good progress. Those court security funds were secured in the 2014 legislative session. During the 2015 legislative session, largely due to the efforts of Senator Perkins and Representative Kroeker, \$1,083,422 was appropriated for court security improvements in eight additional counties: Platte (\$84,429.00), Goshen (\$84,686.00), Niobrara (\$73,778.00), Albany (\$95,355.00), Big Horn (\$371,790.00), Crook (\$82,778.00), Park (\$82,760.00), and Weston (\$207,846.00). These funds were based on assessments that were done by

the National Center for State Courts. The assessments were funded by a grant from the State Justice Institute.

Director Cameron has been in contact with Bridget Hill, the Director of the State Loan and Investment Board (SLIB). Director Cameron suggested the next steps in this process would be to contact all eight counties, provide the application and direct the counties to the website for additional information, and offer any assistance that the counties may need in securing the court security funds from SLIB. Justice Hill moved and Senator Christensen seconded a motion to write letters to the Chair of the County Commissioners in all eight counties, provide the information, and carbon copy the chair of the local courts security committees, the judges and the legislators in the respective counties. Motion carried unanimously. The Commission discussed the fact that there can and should be some follow up with the eight counties, but the responsibility and authority to apply for and spend the funds granted by the legislature is between the counties and SLIB.

Incident Report

Director Cameron emphasized the importance of recording the events that happen in the courthouses around the state. The data that is collected can be a valuable tool in educating and substantiating the need for expenditures and resources to be allocated for court security. Joe Hartigan provided an update on standard 2014-01, incident reporting. The standard was adopted at the December 2014 meeting of the Commission, and Joe emailed the standard and a copy of the incident report form to the chairs of the local court security committees, as well as all judges, clerks and sheriffs. The incident report can be found on the Wyoming Supreme Court website. Joe also reported that he made a presentation to the Chief Clerks of the Circuit Courts regarding the incident report form. Joe reported that the number of incident reports received has already tripled since the new standard was adopted. The Commission had a lengthy discussion about what type of incidents should be memorialized in an incident report. The Commission discussed whether the incident report should be used as an intelligence gathering tool or whether it should only be used to capture actual incidents that occur in the courtroom. Senator Christensen cautioned the Commission that the data used for funding decisions needs to be completely understood by everyone involved so that the data is not devalued. Joe Hartigan, Sheriff Hornecker and Judge Roberts agreed to work on a one page informational sheet that would clarify what should be reported and what does not need to be reported. Sheriff Hornecker agreed to discuss the incident report with the other county sheriffs during an upcoming meeting, and Judge Roberts agreed to discuss the incident report at the circuit judges meeting in Jackson on May 6-8th.

Update on Standard 2009-01

Director Cameron reported that he attended the March 11, 2015 Board of Judicial Policy and Administration meeting. The discussion centered on standard 2009-01 which outlines the makeup of the local court security management committees. He reminded the Commission that last year the BJPA adopted and approved a resolution that conforms to Standard 2009-01, which states that one circuit judge and one district judge shall provide

representation on the local court security management committee in each county. Director Cameron reemphasized the importance of the local committees being actively engaged and being driven by strong leadership. At their April meeting, the District Judges' Conference adopted a resolution that the district judge in each county should chair the local court security committee. Director Cameron reported that the Board members discussed and agreed that the Board's resolution and the district judges' resolution do not conflict. No Commission action was taken on this topic.

Annual Report Template

Director Cameron reviewed the history of the local court security committees and the annual reports that are due from those committees on July 1st of each year. Director Cameron reiterated his belief that the strength of the efforts in court security lies within the efforts that are being carried out by the local court security committees. The local courts security committees are in the best position to identify the strengths and the weaknesses in their communities. In the past, the amount of information contained in the annual reports has varied. The Commission is working to improve the annual report template. Joe Hartigan presented a draft of a new annual report template, containing nine questions. The new template shifts away from the check list format and provides more opportunity for narratives. The Commission discussed two small changes to the new template. Representative Baker discussed a concern that he has about state oversight of the local court security committees and a lack of communication between the local committee and the Court Security Commission. He has additional concerns about the make-up and functionality of the local court security committees. Director Cameron believes that most of the local court security committees are functioning, but agrees that more can always be done. Director Cameron stated that he would reach out to the local court security committee in Sweetwater County. Senator Christensen moved and Justice Hill seconded a motion to adopt the new annual report template as amended. Motion carried unanimously.

Additional Assessments

The Commission discussed the possibility of providing assessments of the remaining 14 courts to be done by the National Center. Judge Roberts moved and Justice Hill seconded a motion to seek additional funds from the State Justice Institute to provide assessments for the remaining county courthouses. Motion carried unanimously.

Next Meeting

The next meeting of the Court Security Commission will be in mid-July; after all of the local court security committee annual reports have been submitted. Judge Roberts mentioned that the formal opening of the new Riverton court complex will be on June 19th, at 1:00 p.m.
