SUBJECT: Annual Report from the Court Security Commission as required by
Wyoming Court Security Act, W.S. § 5-11-101 et seq.

On behalf of the Court Security Commission (Commission), enclosed is the 2023 Court Security Commission Annual Report. This past year, the Commission worked closely with the Wyoming Office of Homeland Security (WOHS) to provide judges with information and training in workplace and personal security.

Over the last several years, the number and intensity of threats and attacks against judges in the United States have increased. Unfortunately, even in the less populated State of Wyoming, we are living in a culture where all manner of public officials are confronted with intimidating behavior, threats, and menacing rhetoric for simply doing their jobs. Threats to physical safety are particularly troubling for judges because the judiciary is a branch of government specifically designed to be insulated from intimidation, harassment, and fear of retribution so that judges can render decisions that are fair, impartial, and independent.

With federal funds granted through the WOHS, the Commission partnered with the Wyoming Supreme Court to host training for the District Judges on April 27, 2023, and the Circuit Court Judges on May 3, 2023. As a part of that training, Judge Julie Kocurek and John Muffler presented information and tactical strategies to help Wyoming judges identify and prevent threats against their person at work and at home.

Judge Kocurek shared her personal experience with the Wyoming Judiciary. She was wounded by a lone gunman outside her home on November 6, 2015, after returning from a high school football game, spent more than a month under hospital care, and underwent more than 30 surgeries to repair injuries from shrapnel and glass. The man convicted of trying to kill her found her home, had photographs of her car and, after surveilling her movements before the attack, was hiding near her house when she and family members returned from the game. Her assailant, a Houston resident, was sentenced to life in prison in March 2018.

John Muffler — a global keynote speaker on threat behavior, risk mitigation, judicial security, and workplace violence — provided a personal security guide, a safety and security checklist, and several articles to the judges. He also provided tips and tricks for a more security-conscious lifestyle.

In addition to providing training to the judges at their spring meeting, the Court Security Commission teamed up with the Wyoming Law Enforcement Academy on July 12, 2023, to provide firearms training to district judges, circuit judges, supreme court justices, and court security personnel. The event was held in Douglas and was well received by those in attendance. The Commission hopes to set up similar training in the future.

Finally, the Commission traveled across the state touring courthouse facilities and speaking to county commissioners in Campbell County, Johnson County, Niobrara County, and Albany County. The Commission also provided testimony to the Joint Judiciary Committee on April 25, 2023, in Sheridan. As a result of that meeting, the Joint Judiciary is considering four bill drafts relating to intimidation of jurors, intimidating or influencing judges, prohibiting the publication of judges' personal information, and the duties of the sheriff and security of the court.

The Commission will continue its important work and stands ready to answer any questions that may arise.

The Wyoming Court Security Commission (Commission), established by W.S. § 5-11-101 et seq., continues its work to enhance court security in Wyoming courthouses by partnering with the Court Security Management Committees (local committees) established by Wyoming Court Security Standard 2009-1.

As one of its main objectives, the Commission focuses its efforts on increasing awareness of potential court security situations and risks associated with courthouses across the state. To address this objective, the Commission adopted Standard 2014-1, Incident Reporting. On January 1, 2015, courts in Wyoming began submitting incident reports for security issues happening in their courthouses. As of July 1, 2023, there have been 489 incident reports submitted. Over this past fiscal year, there were 109 incident reports submitted, which is a 73% increase from the 63 reports submitted in the prior fiscal year, and a 319% increase from the 26 reports submitted two years ago. The incidents reported during the fiscal year 2023 include the following types of security events:

- 30 Disorderly conduct reports;
- 11 Verbal threat reports;
- 11 Medical emergency reports;
- 7 Written threat reports; and
- 50 Other reports of the following incident type: protection order violation; arrest/take into custody; attempt to bring in firearm; suicide attempt; hidden knife; contempt of court; criminal entry; unsecured doors; use of force; fire alarm; safety hazard; lost security key; intoxicated party; suspicious circumstance; panic alarm failure; panic alarm activation; improper court decorum; use of unauthorized devices; improper communication by an attorney.

The submitted report totals this year were significantly higher than all the past years. There has been a stepped-up effort to offer court security training across the state and for members of the State Court Security Commission to visit courthouses in counties across the state to express the importance of security in State Courthouses. This increased awareness has likely resulted in more reports being submitted. It has always been suspected that there are quite a few more incidents taking place than get reported.

Based on the reports the Commission receives, there is every indication that courthouses present special challenges in terms of security. In the past year, reports involving verbal and written threats increased by 80% while disorderly conduct reports increased by 58%. While there may be several reasons behind the increase in incident reports, the stories told in the reports reflect the absolute need for a solid physical security presence in all courthouses across the state. It is fortunate that the case of a loaded firearm being

detected by court security officers was in a courthouse utilizing an X-Ray machine. It is hard to say what may have happened had that incident taken place in a courthouse with no regular court security presence.

To effectively address the security issues in Wyoming courthouses, a collective knowledge of these incidents and security events is imperative and emphasizes the importance of having adequate security in every courthouse. The incident reports provide an important tool for local court security committees in identifying what actions were effective in each incident and what security practices need to be improved.

<p>Joint Judiciary Meeting Justice Fenn</p>	<p>Justice Fenn met with the Joint Judiciary (JJC) in Sheridan on April 25th. The information discussed was well received by the JJC: Proposed legislation involving language in Wyo. Stat. Ann. § 6-5-305(a), a better definition of Sheriff's security duties, and personal information protections. The JJC also discussed additional manpower and training for county sheriffs and home security systems for judges.</p> <p>Representative Washut confirmed the information was well received, however, he cautioned the Commission that unfunded mandates for the counties and carving out special classes of individuals could receive pushback from the committee.</p> <p>Senator Nethercott advised that the timing of any request for appropriation is critical. If funds are to be requested, it would be beneficial to contact the County Commissioners Association and get a plan formulated. She informed the Commission that currently there are other situations where there is joint funding (county/state) for programs throughout the state. The first meeting of the Joint Appropriations Committee will be in July.</p>

	<p>Sweetwater County Attorney Dan Erramouspe hopes that any discussions regarding courtroom security will include the other individuals involved in the justice process: attorneys, litigants, staff, etc. He recommended reaching out to the local bar members to raise awareness about security issues in the courthouses.</p>
