INTRODUCTION

Welcome to the Wyoming Judicial Branch's Annual Statistical Report for fiscal year 2023. This report offers a concise overview of the state's judicial system, highlighting key data and insights into the circuit court caseload providing essential information on caseloads and comparisons to previous reporting periods. The Judiciary aims to foster trust and understanding while showcasing our dedication to data-driven decision-making.

METHODS

This report's data is defined by the following criteria, focusing on case statistics for circuit courts within fiscal year 2023 (July 1, 2022 – June 30, 2023). The approach involves using a statistical model provided by the Court Statistics Project (CSP). The CSP model enables the Wyoming Judicial Branch to effectively compare its case statistics with those of other states and national trends.


The CSP framework comprises over 80 different case types, which, for year-to-year comparisons and high-level analysis, can be overwhelming. To enhance readability and analysis, case types have been condensed into 6 case categories for circuit courts, grouping similar case types together.


In the interest of clarity, the counting method has been adjusted from the CSP model to allow for increased readability and understanding. All case counts are based on the number of new filings, irrespective of the number of participants in each case.

To provide a more comprehensive view of caseload trends, the caseload statistics using this methodology for FY21 and FY22 are included, enabling valuable comparisons over time.

These refinements in data collection and reporting methodology aim to offer a clearer and more relevant perspective on the judicial activities within Wyoming's circuit courts.


