**ORDER CREATING AND APPOINTING MEMBERS TO THE  
LEGISLATIVE RELATIONS COMMITTEE**

**THIS MATTER** came before the Wyoming Judicial Council, and the Wyoming Judicial Council deeming it necessary and proper to create a Legislative Relations Committee. It is therefore,

**ORDERED** that there be, and hereby is, a Legislative Relations Committee to review and recommend legislative priorities to the Wyoming Judicial Council ensuring a coordinated approach to the Wyoming Judicial Branch's message to the Legislature. It is therefore,

**ORDERED** that the Legislative Relations Committee voting members shall consist of the Chief Justice or designee, two district court judges and two circuit court judges. Membership terms shall be two years and initial terms shall be staggered for each of the conferences to ensure continuity. Members may serve consecutive terms; and it is further

**ORDERED** that the Legislative Relations Committee shall consist of the following members:
