



**ORDER CREATING AND APPOINTING MEMBERS TO THE
TECHNOLOGY COMMITTEE**

THIS MATTER came before the Wyoming Judicial Council, and the Wyoming Judicial Council deeming it necessary and proper to create a Technology Committee. It is therefore,

ORDERED that there be, and hereby is, a Technology Committee to make recommendations to the Wyoming Judicial Council concerning the Technology policies, needs, and vision of the Wyoming Judicial Branch. It is therefore,

ORDERED that the Technology Committee voting members shall consist of one Supreme Court Justice appointed by the Chief Justice, one district court judge recommended by the District Court Conference, one circuit court judge recommended by the Circuit Court Conference, one Clerk of District Court recommended by the President of the Clerk of District Courts' Association, and one Circuit Court Chief Clerk to be recommended by the President of the Wyoming Association of Circuit Court Clerks. Membership terms shall be three years and initial terms shall be staggered for each of the conferences to ensure continuity. Members may serve no more than two consecutive terms; and it is further

ORDERED that the Technology Committee shall consist of the following members:
